Transition Council of Iran

Summary

The Transition Council of Iran (The Council) will be empowered by the Iranian people to serve as a supervisory body after neutralization of the Islamic Republic (of Iran). The Council is made up of 24 Supervisory Groups that oversee the daily affairs of the government ministries and organizations. Each Supervisory Group is responsible for a specific aspect of running the country.

The Council will facilitate the establishment of a modern and democratic republic based on the United Nations' Universal Declaration of Human Rights. Subsequently, The Council will organize a fair, transparent, and accurate election for the Iranian people to elect their future government. The election is expected to be held within less than 12 months from when The Council starts its operation. Once the new government is formed and ready to operate, The Council will be dissolved, and the newly-elected government will take charge of the country.

Our Goals

- ❖ Prevent an outbreak of a military confrontation between the USA and Islamic Republic
- ❖ Free the Iranian people from decades of oppression and tyranny
- ❖ Re-establish strong diplomatic and economical ties between the USA and Iranian people
- ❖ Bring peace and prosperity to the Middle East
- ❖ Eradicate extremist ideologies and terrorism

Mandates of The Council

- ❖ Full compliance with the 12 conditions imposed by the current USA Administration for lifting sanctions against Iran
- ❖ Safeguarding the territorial integrity of Iran
- ❖ Overseeing the day-to-day running affairs of the country
- ❖ Instilling a safe and conducive environment for the individual activists and political parties to raise public awareness about social issues
- ❖ Facilitating the foundation of a modern and democratic republic
- ❖ Preparing, coordinating and conducting a fair, transparent, and accurate election for the Iranian people to freely elect their future government
- ❖ Assisting the future government to take charge of the country, and finally dissolving The Council



The Council's Goodwill

- ❖ During the transition period, no execution sentence will be ordered by the courts, and all previously-approved execution sentences will be placed on hold until the next elected government rules on this subject
- ❖ The Council will do its best to restore the life of citizens to normal as soon as possible
- ❖ The Council forbids any action that may negatively affect the legal income and assets of the citizens
- ❖ All rank-and-file employees of government-related organizations will continue their employment
- ❖ Payment of pensions, subsidies, and government-provided monetary assistances will be continued as before
- ❖ All legally-binding agreements made by the Islamic Republic with individuals, private businesses, and foreign companies will be honored

The Council's Authority and its Limitations

- ❖ All rank-and-file employees of government-related organizations are required to remain in their posts, and collaborate with The Council
- ❖ Cooperation of all citizens, private businesses, and government organizations with The Council is mandatory to prevent social tension and crises. Those disobeying the laws or attempting to disrupt normal life will be subject to prosecution
- ❖ All political prisoners will be freed and dealt with in accordance with the guidelines outlined in Appendix A
- ❖ High-ranking members of the regime, and ideologically-driven organizations of the Islamic Republic will be dealt with in accordance with the steps outlined in Appendix B
- ❖ The Council will suspend the Islamic Consultative Assembly (The Parliament), and will NOT enact any new laws. The Parliament will resume its role in accordance with the laws of the future government of Iran

The Council's Authority and its Limitations (continued)

- ❖ The Council will appoint 31 new Province Governors (Ostandar) for each of the 31 provinces of Iran
- ❖ The newly-appointed Province Governors will have the authority to appoint new County Governors (Farmandar) for each of the 404 counties in Iran, or retain the existing County Governor. Any County Governor and associated subordinates who cooperate with The Council prior to the deposition of the Islamic Republic will retain their position
- ❖ The Council will have the authority to appoint new chiefs for the Armed Forces
- ❖ The newly-appointed County Governors will have the authority to appoint new chiefs for the local Armed Forces and Police

Method of Operation

- 1) The Council finalizes its organization, and appoints all key members
- 2) The Council publicly announces its existence by introducing itself to the international community
- 3) While in exile, The Council will liaison with world powers to promote its agenda
- 4) Once The Council's identity is recognized, the Iranian people will be called up on to empower The Council
- 5) Upon empowerment, The Council will coordinate its tactical plan with supporters inside Iran, and will call for a National Uprising to take control of the country
- 6) The Council will be dispatched to Iran to assume its duties

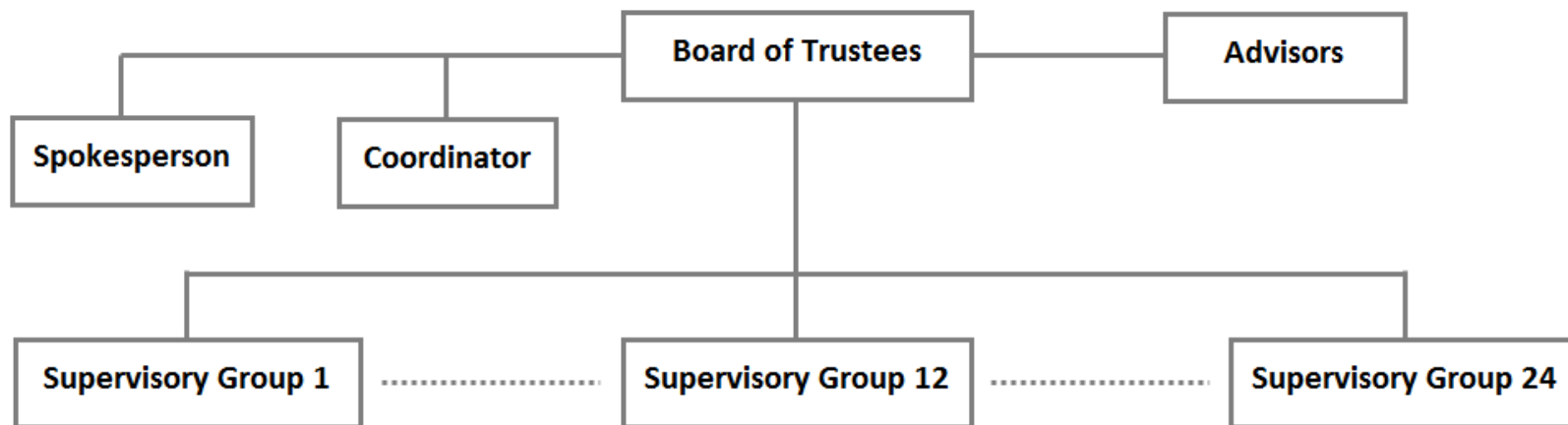
Financing The Council

- ❖ All expenses needed by The Council while in exile will be borne by its members
- ❖ Once The Council is established in Tehran, all expenses for setting up the offices and conducting the operation of The Council will be covered by the nation's wealth (reserves, oil/gas revenue, etc.)
- ❖ During the transition period, the members of The Council will be compensated only for those expenses that are directly related to their duties. Such expenses include, for example, lodging, meals, travel, and incidentals



Organizational Structure of The Council

- ❖ The Council is headed by The Board of Trustees (The Board) that has 3 members. The Board will internally-appoint one of its members as The Chairman. Also, The Board will appoint the Advisors, Coordinator, and Spokesperson
- ❖ The Council has 24 Supervisory Groups that will be stationed in Iran. These groups are directly engaged in the running of the daily affairs of the country

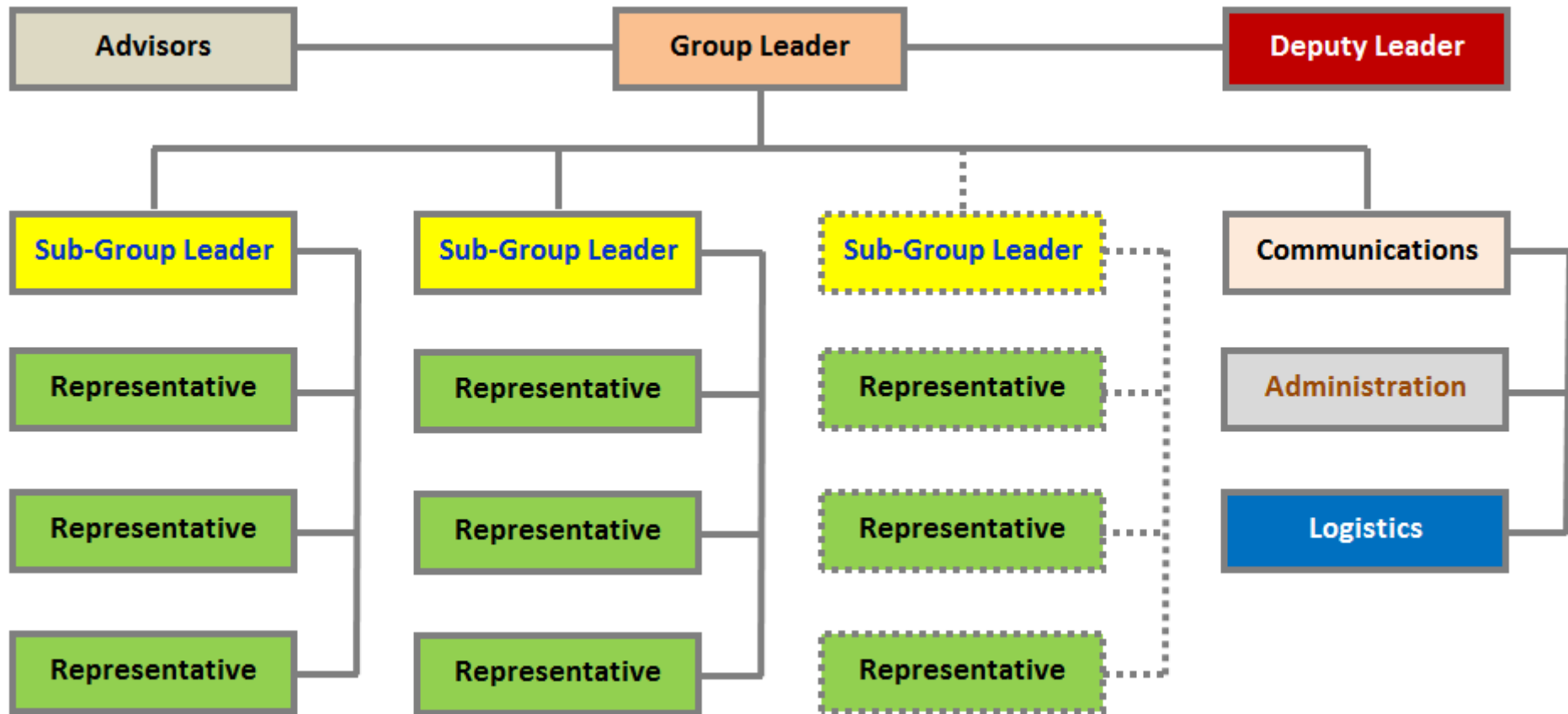
The Council's Scope of Supervision

- ❖ Each Supervisory Group will be responsible for one of the fields of operation listed in the table shown below
- ❖ Under the guidance of the Board of Trustees, all groups will collaborate with each other to run the country as smoothly as possible during the transition period

Summary of Supervisory Group's Scope of Duties

Supervisory Group's Members	
Position	Duties
Group Leader	Guidance, management and operational affairs of the group
Deputy Leader	Assisting the Group Leader, and resuming the responsibility of the Group Leader in his/her absence
Sub-Group Leader	Guidance, management and operational affairs of the sub-group in accordance to the Group Leader's instructions
Representative	<ul style="list-style-type: none">▪ Active presence, and effective participation in the daily management of the assigned government-related organization by utilizing the knowledge and experience of the existing organization's employees▪ Ensuring smooth operation of the assigned organization, and preventing the occurrence of any crisis
Communications	Organizing and executing all steps related to the group's documents, notifications, and announcements
Administration	Running the group's office, and providing administrative services
Logistics	Organizing and facilitating all services required by the group in accordance to the Group Leader's instructions

Requirements for the Members of the Supervisory Group

Supervisory Group's Members	
Position	Requirements
Group Leader	Reliable and experienced, capable of building and managing a team, a true believer in team-work
Deputy Leader	Reliable, energetic, goal-oriented, and resident of Iran
Sub-Group Leader	Reliable and experienced, patient, and knowledgeable about the technical aspects of the organizations to be assigned to
Representative	Reliable and highly-active, open-minded, knowledgeable about the technical aspects of the organization to be assigned to, and resident of Iran
Communications	Reliable , knowledgeable and experience with communications affairs, and resident of Iran
Administration	Reliable , knowledgeable and experience with administrative tasks, and resident of Iran
Logistics	Reliable, highly energetic, task-oriented, good organizational skills, and resident of Iran

Supervisory Group's Management

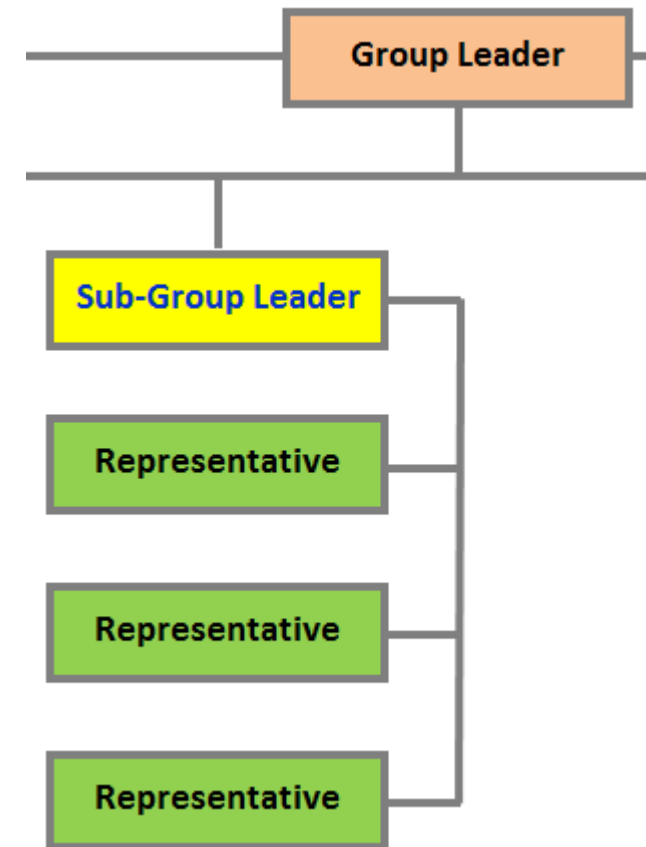


- ❖ The team comprising the Group Leader, Deputy Leader, and Advisors form the core of the group. The team is responsible for all main decision-making steps
- ❖ The Group Leader will select the Advisors from the pool of knowledgeable and experienced intellectuals living in Iran and abroad. The Advisors will be independent, and shall provide their expertise to the Group Leader, as requested.
- ❖ The Group Leader will appoint his/her Deputy, and shall utilize the Deputy to perform the duties of the associated group, as appropriate
- ❖ The Group Leader will form as many sub-groups as needed to execute the duties of the associated group



Sub-Group's Organizational Structure

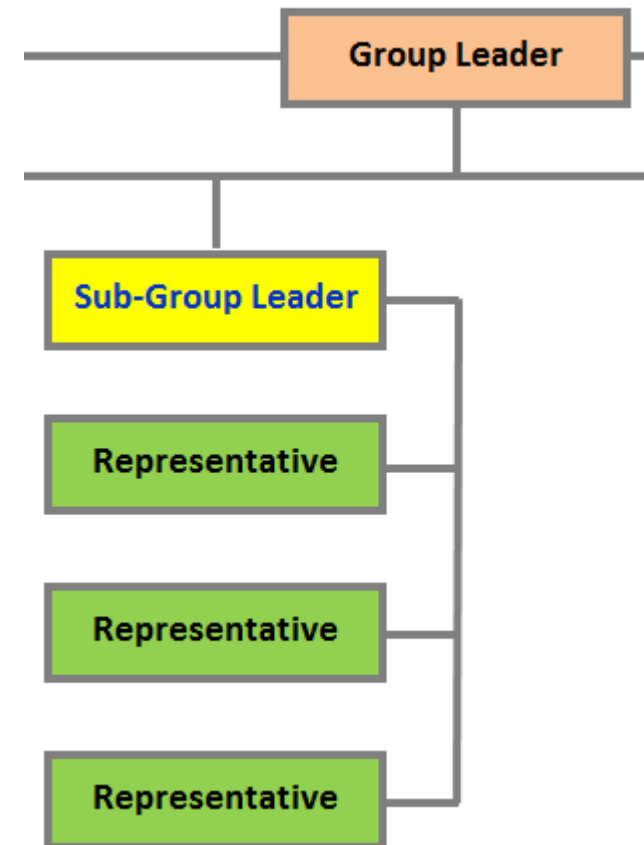
- ❖ Each Supervisory Group is made up of several Sub-Groups. The exact number of such Sub-Groups is decided by the Group Leader
- ❖ Each Sub-Group consists of a Sub-Group Leader who leads 3 Representatives. These Representatives are appointed by the Sub-Group Leader, but the appointment must be approved by the Group Leader
- ❖ The Sub-Group Leader shall provide sufficient resources to The Representatives so that they can perform their duties efficiently





The Representative's Main Role

- ❖ Each Representative will oversee the operation of a government-related organization
- ❖ The Representative will serve as the “Eyes-and-Ears” of the group in the assigned organization
- ❖ The Representative will work closely with the staff of the assigned organization to ensure smooth flow of the operations

Process of Establishing The Council in Tehran

- ❖ Upon the fall of the Islamic Republic, The Council will dispatch the 24 Group Leaders to Tehran as soon as it is reasonably safe for these individuals to arrive
- ❖ Within 48 hours of arrival, each Supervisory Group Leader will appoint his/her Deputy Leader and Advisors
- ❖ With the next 24 hours, the Communications, Administration, and Logistics Officers will be retained
- ❖ The available team members will setup their office in the building of the government ministry that closely matches their field of operation
- ❖ Within the next 48 hours, the Group Leader will form the required Sub-Groups, and declare his/her group as operational
- ❖ The Group Leader will report the status of the group to the Board of Trustees on a daily basis



Appendix A : Declaration of a National Pardon

- 1) All political prisoners and prisoners of conscience will be freed, and all records of their imprisonment will be expunged
- 2) No rank-and-file government employee will be prosecuted for following inhumane orders, such as torture or execution
- 3) All Iranian citizens, regardless of any political, religious or ideological belief that they may have supported in the past, will be allowed to freely return to Iran, and if they wish, leave the country without any restrictions. This concession will NOT cover those who have committed (or allegedly committed) criminal or judicial crimes



Appendix B : Dissolution of the Islamic Republic

The Council will handle the abolition of all foundations, organizations and other government-related entities according to the following steps:

- 1) Termination of the office of the Supreme Leader (Ali Khamenei)
- 2) Termination of the offices of the Guardian Council, Assembly of Experts, and Expediency Discernment Council
- 3) Termination of the Revolutionary Guard (IRGC) and Basij forces

The details of the above-mentioned steps are provided in the subsequent pages.



Appendix B : Terminating the office of the Supreme Leader

- 1) The Supreme Leader (Ali Khamenei) will be discharged from power, and no replacement will be appointed to the position of the Supreme Leader
- 2) All organizations and entities belonging to the office of the Supreme Leader will cease their operation
- 3) All assets of these organizations under the control of the Supreme Leader will be transferred to the Iranian National Treasury
- 4) All personnel of the ceased operations will be retired. Those qualified will receive a retirement pension in accordance to the Iranian employment laws
- 5) All complaints and litigations matters concerning the Supreme Leader and his office will be dealt with by the next elected government

Appendix B : Termination of the offices of the Guardian Council, Assembly of Experts, and Expediency Discernment Council

- 1) The offices of the Guardian Council, Assembly of Experts, and Expediency Discernment Council will cease their operations, and no other government or private organizations will resume their authorities
- 2) The assets of the above-named organizations will be transferred to the Iranian National Treasury
- 3) All personnel of the above-named organizations will be retired. Those qualified will receive a retirement pension in accordance to the Iranian employment laws
- 4) All complaints and litigations matters concerning the above-mentioned entities will be dealt with by the next elected government



Appendix B : Termination of the Revolutionary Guard (IRGC) and Basij

- 1) The service of all Basij members will be terminated
- 2) The assets of the Basij organization will be transferred to the Iranian National Treasury
- 3) Members of the Revolutionary Guard will be considered for consolidation into the Armed Forces and Police in accordance with the individual's qualifications as well as the requirements and employment terms of the involved forces. Those not qualified for the above-mentioned consolidation may be utilized in other government organizations, subject to their suitability and qualifications. All members who are over 45 years of age can opt for retirement, and receive a pension in accordance with the Iranian employment laws
- 4) All assets of the Revolutionary Guard will be transferred to the Iranian National Treasury
